"What does United Way do?" Well, we do so many things that it's hard to summarize them in just a few words. But when I have to, I describe us as "a local think tank for helping people." Our volunteers and our partner agencies constantly comb through articles and research to keep in touch with the greatest human needs in central Louisiana. But we do more than just think – we forge solutions and put them into action.

For example, we need more youth to graduate high school. We've been longtime funders of great programs at agencies such as the Boy Scouts, Girl Scouts, and YWCA, which equip children and youth with a broad range of knowledge and skills for success. But we can't wait until someone's in high school to start preparing them. We also fund a proven program at the Volunteers of America called "Parents as Teachers," which works closely with young, at-risk parents to help them and their preschool children succeed. We've just embarked on a journey to help elementary school students learn personal responsibility and soft skills through a program called "The Leader in Me," based on Stephen Covey's Seven Habits of Highly Effective People.

We all need financial stability. Right now we have IRS-certified staff and volunteers doing tax returns at no charge for low-income families, saving them hundreds of dollars and bringing tax refunds back into our local economy. We're working to set up a financial counseling service so that folks can better deploy the resources they have.

Next time I'll tell you more about our funding for programs in health and in basic needs like food, shelter, and personal safety. We're active in responding to disasters, in connecting people with the services they need, and in helping community organizations achieve higher levels of excellence. But in all we do, we act as a local coalition of agencies, businesses, donors, and volunteers. CLECO DONATES TO LAUNCH 2-1-1



On January 31, 2018, Cleco awarded United Way of Central Louisiana \$150,000 to launch a 2-1-1 call center. 2-1-1 is a free, confidential referral and information helpline and website that connects people from all communities and of all ages to the essential health and human services they need, 24 hours a day, seven days a week.
